#### Liquor Prescription Blanks Are Called In


Monday is the last day on which the existing stocks of liquor prescriptions will be honored by drug stores.

Early in April Knight's Camp, through the County Medical Association of Los Angeles County, offered free room and board to doctors. In turn, each doctor was to have a two weeks' vacation, charge his own fees. The only responsibility Knight's Camp took in the matter was to furnish room and board.

In this connection there were some disappointments. Doctors failed to arrive on schedule, leaving the Valley without medical aid for odd days; some doctors seemed rather unscrupulous in their charges. However, taking it all into consideration, as a whole the plan has been successful. Next year, if the idea is continued, we will be in a better position to pick and choose from the various doctors; keep a doctor in at all times, no schedule mixup, etc.
